> Description, objectives and target outcomes of the session:

The session will present the latest environment and health assessment reports and its main findings and recommendations. The session will discuss evidence-based scientific results of the global and regional consultative and participatory environmental assessment processes that are based on recent scientific information and data. Speakers will highlight the scientific assessment findings of the three global conventions namely the UNCCD, the United Nations Framework Convention on Climate Change (UNFCCC), and the Convention on Biological Diversity (CBD). Assessment reports include Global Environment Outlook, Africa Environment Outlook, WHO Health and Climate Change Survey, Emissions Gap, WMO United in Science and other regional assessment reports analyzing current and past environmental policies and identifying future options. Panelists will share their vision on the future modality of work to interconnect and harmonize the three conventions towards facing the ecosystem and climate challenges. Speakers will highlight the possible scenarios and transformative approaches that humanity can take to achieve healthy planet. Speakers will discuss how the findings of these reports and conventions are affecting the global decision/policy-making process to achieve the 2030 Agenda for Sustainable Development and internationally agreed climate change goals and targets.
